

#### **Instructions to candidates**


Students listed in the Fourth Merit List have to appear for CAP Round 4 in **offline mode only**, **Thurday**, **July 18<sup>th</sup> 2025**, at the **Venue**: Seminar Room, Dept of IT, 3rd Floor, Dr. Shankar Dayal Sharma Bhavan (IDOL), Vidyanagari, Santacruz(E), Mumbai – 400098 according to the following **Timings**: 11:00 AM to 1:00 PM and 2:00 PM to 5:00 PM.

#### **Important Instructions Regarding the Admission Process**

- **1. Merit List Declaration:** The Merit List has been prepared strictly in accordance with the rules and regulations prescribed by the Government of Maharashtra and the University of Mumbai.
- **2. Compulsory Attendance for CAP Round I:** Candidates who fail to report for CAP (Centralized Admission Process) Round II shall be deemed to have forfeited their claim for admission. Such candidates will not be considered in any subsequent rounds of the admission process.
- **3. Specialization Seat Allocation In-Person Requirement:** Students who have applied for more than one program offered by the department are required to firmly choose their preferred program during the CAP Round itself. The final selection of the program must be made strictly at the time of reporting for CAP, and no changes shall be permitted thereafter.
- **4. Candidates Listed in Fourth Merit List:** Candidates whose names have appeared in the Third Merit List will not be eligible for consideration in any further rounds. They are therefore advised to confirm their admission by remitting the prescribed fees through the online admission portal within the stipulated time. **Note:** No extension shall be granted beyond the specified deadline. Failure to make the fee payment within the given period will result in exit from the admission process without any further notice.
- **5. Fee Payment Guidelines:** Please note that no provision for payment in installments is available for the fee payment. The entire fee must be paid in full as per the admission instructions.
- **6. Students Interested in Applying to St. Louis University, USA (Second Year):** A dedicated counselling counter will be made available during the CAP Round for students intending to apply for the second-year program at St. Louis University, USA. Such students are advised to approach the designated counter for further guidance.

- 7. Provisional Admission for Students from Other Universities (M.S. Cyber Security): Candidates from universities other than the University of Mumbai seeking admission to the Master of Science (Cyber Security) program are hereby informed that their admission shall remain provisional, subject to confirmation of eligibility by the University's Eligibility Section.
- **8. Verification of Original Documents Mandatory:** The mere appearance of a candidate's name in the Fourth Merit List does not confer any right to admission, unless and until all original documents are physically verified and found to be in order.


